CALL FOR BLOGS

The Centre for Law and Urban Development, National Law University Delhi, invites submissions for its blog series on a rolling basis. We welcome contributions from scholars, practitioners, policymakers, and students on various themes related to the intersection between law and urban development. The submissions should offer insightful analysis, critical perspectives, and innovative solutions on recent developments in the field.



THEMES

- <u>Real Estate & Housing Policy</u> Exploring legal frameworks, redevelopment and regulatory incentives that shape affordable housing and urban inclusion.
- <u>Urban Taxation & City Finance</u> Analysing property tax systems, development incentives, infrastructure levies, and compliance reforms driving equitable urban growth.
- <u>Healthcare & Pharma Regulation</u> Examining policy frameworks, health infrastructure planning, and regulatory mechanisms shaping access to healthcare and medical innovation in cities.
- <u>Urban Project Financing & Insolvency Frameworks</u> Assessing how insolvency law, banking regulations, SEBI frameworks, REIT mechanisms and other financing models influence real estate and infrastructure projects in urban India.
- <u>Collaborative Models for Urban Infrastructure</u> Reimagining PPP frameworks through effective risk-sharing, public interest safeguards, and policy innovations for resilient city projects.
- <u>Smart Cities & Digital Infrastructure</u> Unpacking the policy and legal frameworks governing data, IoT, and connectivity in the next generation of urban development.
- <u>Green & Sustainable Cities</u> Analysing regulations and incentives for green buildings, climate-resilient planning, and environmentally sustainable urban governance.
- <u>Construction & Materials Regulation</u> Exploring building codes, quality standards, and the role of core industries in shaping safe and efficient urban infrastructure.
- <u>Power, Water & Urban Utilities</u> Reviewing regulatory reforms in electricity, water, and waste management to improve delivery, accountability, and city sustainability.

Please note that the above themes are only indicative and not exhaustive, and there is no strict requirement that the submission needs to fall under the above heads. The submissions must be analytical in nature and not descriptive.



Word limit: Articles can be anywhere between 800 to 1500 words. In case a relaxation in word count is required, please write to us so that we can consider your request.

<u>Use of images</u>: Images, graphs and tables may be used wherever necessary to illustrate a point. Authors are encouraged to include relevant case studies, empirical data, or policy analysis to support their arguments.


<u>Abstract</u>: An abstract no longer than 50 words, briefly describing the content of the blog, needs to be sent along with the submission. Please note that the abstract should be sent separately and not as part of the main blog.

<u>Author details</u>: Please include a brief author bio of around 100 words along with a high-resolution photo with the submission. A link to the LinkedIn Profile of the author (if existing) also needs to be attached.

Co-authorship: Co-authorship of up to two authors is allowed.

Formatting and Referencing Guidelines

- The text needs to be formatted according to these guidelines: Font Times New Roman, Font Size 12, Line Spacing 1.5, Paragraph Spacing 6 above and 6 below.
- Title must be Bold and Underlined. The text of the title must be in Sentence Case, not all caps or small caps. Heading 2 must be Bold and Heading 3 must be underlined.
- Margins must be one inch from all sides. No borders are permitted.
- Any supporting materials or legal materials used by the author need to be referenced through the use of hyperlinks, which need to be included in the body of the text.



- The file needs to be only in the .doc / .docx format and must be named as "Title_CLUD Blog".
- The title must not exceed 10 words and must briefly describe the content of the blog.
- Metadata of the file must not disclose any identification of the author, including name and institutional affiliation.
- All submissions need to be mailed to clud@nludelhi.ac.in with the subject line: "Submission for Centre for Law and Urban Development Blog Series."

Plagiarism and Author Agreement

- Submissions need to be to the original work of the author. The submissions will be screened by plagiarism and AI detection software, and if found to be unoriginal, will be rejected for publication.
- The author is responsible for ensuring the accuracy of facts, opinions or views in the submission.
- CLUD reserves the sole right to make decisions on the publication of any content submitted. Relaxation of any rules regarding submissions is subject to the discretion of the Centre. On publication, all literary rights to the submission are transferred to the Centre for Law and Urban Development, NLU Delhi.
- The call for submissions is ongoing, and contributions will be accepted on a rolling basis. Authors will be notified of the status of their submissions within two weeks from the date of submission. Adhering to all the formatting and submission guidelines is mandatory.
- We look forward to receiving your insightful contributions and fostering meaningful dialogue on the critical issues at the juncture of law and urban development.
